Note: If multiple symptoms, exclude child for any positives.

**Key**

- Parents should consider seeking medical attention.
- \*\*Child will need a health professional's note to return to school.
- ☺ Health clerks and teachers should report these promptly to the school nurse, who in turn, will evaluate symptoms and report to Public Health as needed.

SYMPTOM	TEMPORARILY EXCLUDE?
<b>Cold Symptoms</b>	<b>No, unless</b> <ul style="list-style-type: none"> <li>✓ Fever and behavior change •</li> <li>✓ Child looks or acts very ill •</li> <li>✓ Difficulty breathing •</li> <li>✓ Blood red or purple rash not linked to an injury •</li> </ul>
<b>Cough</b>	<b>No, unless</b> <ul style="list-style-type: none"> <li>✓ Severe cough •</li> <li>✓ Rapid and/or difficult breathing •</li> <li>✓ Wheezing if not previously evaluated and treated •</li> <li>✓ Cyanosis (blue color of skin and mucous membranes) •</li> <li>✓ Tuberculosis until treated ** ☺</li> <li>✓ Pertussis until 5 days after antibiotic treatment ** ☺</li> </ul>
<b>Diaper Rash</b>	<b>No, unless</b> <ul style="list-style-type: none"> <li>✓ Oozing sores that leak body fluids outside the diaper •</li> </ul>
<b>Diarrhea</b>	<b>Yes, if</b> <ul style="list-style-type: none"> <li>✓ Child wears diapers •</li> <li>✓ Watery stools, increased frequency •</li> <li>✓ Diarrhea not contained in toilet until resolves •</li> <li>✓ Blood/mucus in stool (unless from medication or hard stools) •</li> <li>✓ Abnormal color of stool for child • (i.e. all black or very pale)</li> <li>✓ No urine output in 8 hours •</li> <li>✓ Jaundice (i.e. yellow skin/eyes) • ☺</li> <li>✓ Fever with behavior changes •</li> <li>✓ Looks or acts very ill •</li> </ul> <p>(Shiga-toxin producing <i>E. coli</i> (STEC) also known as enterohemorrhagic <i>E.coli</i> (EHEC), <i>Shigella</i> and <i>Salmonella typhi</i> (typhoid) require clearance by health department prior to return to school) ** ☺</p>
<b>Difficult or Noisy Breathing</b>	<b>Yes, if</b> <ul style="list-style-type: none"> <li>✓ Hard, fast, difficult breathing that does not improve with any medication the program has been instructed to use for child's difficult breathing •</li> <li>✓ Barking cough with fever or behavior changes •</li> <li>✓ Chest retractions •</li> <li>✓ Breathing problem that makes feeding very difficult •</li> <li>✓ Looks or acts very ill •</li> </ul>
<b>Earache</b>	<b>No, unless</b> <ul style="list-style-type: none"> <li>✓ Unable to participate •</li> <li>✓ Fever with behavior changes •</li> </ul>
<b>Eye Irritation, Pinkeye</b>	<b>Yes, if</b> <ul style="list-style-type: none"> <li>✓ Purulent (pink or red conjunctiva (whites of eyes) with white or yellow mucus), or diagnosed with bacterial conjunctivitis, until treated **</li> </ul> <p>If more than 1 or 2 children in group have watery red eyes without chemical irritant exposure, exclusion may be required and health authorities should be notified ** ☺</p>
<b>Fever</b> <ul style="list-style-type: none"> <li>✓ 100°F axillary – infants •</li> <li>✓ 101°F orally (not reliable under 4 years of age) •</li> <li>✓ 102°F rectally •</li> </ul> <p>Ear measurements may not be reliable but are similar to rectal temperatures.</p>	<b>No, unless</b> <ul style="list-style-type: none"> <li>✓ Behavior change •</li> <li>✓ Child cannot comfortably participate in school activities, as determined by staff •</li> <li>✓ Staff attention to the illness must not overwhelm delivery of care/education to other children •</li> </ul> <p>Temperatures considered elevated above normal, leading to concern of possible disease (children older than 4 months) •</p>

SYMPTOM	TEMPORARILY EXCLUDE?
<b>Headache</b>	<b>No, unless</b> ✓ Child is unable to participate in school activities, as determined by staff •
<b>Itching</b>	<b>Yes, if</b> ✓ Head lice (at end of day until first treatment; no exclusion for nits) • ✓ See under “Rash” for chickenpox, shingles, scabies, impetigo, ringworm.  <b>No, unless appears infected</b> ✓ Pinworm • ✓ See under “Rash” for eczema, contact or allergic dermatitis.
<b>Mouth Sores</b>	<b>No, unless</b> ✓ Inability to swallow • ✓ Excessive drooling with breathing difficulty • ✓ Fever with behavior changes •
<b>Rash</b>	<b>Yes, if</b> ✓ Rash with behavior change or fever • ✓ Oozing/open wound • ✓ Bruising not associated with injury • ✓ Joint pain and rash • ✓ Unable to participate in school activities • ✓ Measles until 4 days after start of rash ** ☺ ✓ Rubella until 6 days after onset of rash ** ☺ ✓ Chickenpox (Varicella) until all lesions have dried (usually 6 days) ** ✓ Scabies until treated ** ✓ Impetigo until treated for 24 hours ** ✓ Ringworm (at end of day until treatment started) • <b>No, unless appears infected</b> ✓ Allergic or irritant reactions • ✓ Eczema • ✓ Shingles (must be able to keep lesions covered with clothes and/or dressing). •
<b>Sore Throat (pharyngitis)</b>	<b>No, unless</b> ✓ Inability to swallow • ✓ Excessive drooling with breathing difficulty • ✓ Fever with behavior change •
<b>Stomachache</b>	<b>No, unless</b> ✓ Severe pain causing child to double over or scream • ✓ Abdominal pain that continues after two hours • ✓ Abdominal pain after injury • ✓ Bloody/black stools • ✓ No urine output for 8 hours • ✓ Diarrhea • ✓ Vomiting • ✓ Yellow skin/eyes ** ✓ Fever with behavior change • ✓ Looks or acts very ill •
<b>Swollen Glands (Lymph Nodes)</b>	<b>No, unless</b> ✓ Difficulty breathing or swallowing • ✓ Red, tender, warm glands • ✓ Fever with behavior change • ✓ Mumps, until 9 days after swelling of parotid glands • ☺
<b>Vomiting</b>	<b>Yes, if</b> ✓ Vomiting 2 or more times in prior 24 hours • ✓ Fever • ✓ Vomit that appears green/bloody • ✓ No urine output in 8 hours • ✓ Recent history of head injury • ✓ Looks or acts very ill •
<b>Other</b>	<b>As per Health Dept. during outbreak</b> <b>Yes, if</b> ✓ Hepatitis A until 1 week after onset of illness or jaundice ** ☺
